## Section I Invitation to Bid

### Introduction

## **Bid Conditions**

1. Bidders are advised to study the bid document carefully. Submission of Bids shall be deemed to have been done after careful study and examination of the Bid Document with full understanding of its implications.
2. The Bidder must furnish Tender Document Fee for Rs.10,000/- (Ten Thousand only) in favor of **EdCIL India Ltd.** “Payable at **Noida (U.P.)** in the form of Demand Draft, failing which the bid will be rejected.
3. The Bidder must furnish Earnest Money Deposit (EMD) for Rs.500,000/- (Five Lakh only) in favor of **EdCIL India Ltd.** “Payable at **Noida (U.P.)** in the form of Demand Draft, failing which the bid will be rejected.
4. The tender documents is not transferable
5. The bids of only those bidders, who have purchased the tender document in their names, will be considered.
6. EDCIL reserves the rights to reject any bid or all the bids without assigning any reasons.
7. The bidder will accept all conditions of the tender document unconditionally or depending upon the decision of the Tender Evaluation Committee.
8. Financial bids of only the technically qualified bidders will be opened and scrutinized.
9. Validity of the Bid is **60 days** from last date of submission of bid.

Note: The client shall be responsible for any postal delays about non-receipts/ non-delivery of the documents. All late bids/ incomplete bids would be rejected out rightly.

## Section-II

### Instructions to the bidder

#### 1. Eligibility Criteria for the Bidder

The bidder must qualify the following eligibility criteria and documentary proof for each should be enclosed with the Technical Bid.

## **2. Procedure for Submission of Bids**

- 2.1. The Bidders must place their technical and commercial proposals in 2 separate sealed envelopes, super-scribed as follows:
  - A. Technical Proposal
  - B. Commercial Proposal
- 2.2. The Bidder shall have to qualify the eligibility criteria on the basis of documents to be submitted in Technical proposal for further shortlist for examination of financial bids.
- 2.3. Technical proposal will be opened on the prescribed date and time.
- 2.4. Please note that commercial aspects (prices, cost etc.) should not be indicated in the Technical Proposal and should be quoted only in the Commercial Proposal.
- 2.5. The Commercial Proposal should be covered in a separate sealed cover super-scribing the “Commercial Proposal”. The Commercial proposal should only be submitted in the prescribed format.
- 2.6. The cover thus prepared should also indicate clearly the name and address of the Bidder to enable the Bid to be returned unopened in case it is received “Late” or due to any other reason.
- 2.7. The bids received late and declared late by the Bid Evaluation committee after the last date and time for receipt of bids prescribed in the bid document or otherwise shall be rejected and/or returned unopened to the Bidder.
- 2.8. Each copy of the bid should be a complete document with Index & page numbering and should be bound as a volume. Different copies must be bound separately.

## **3. Cost of Bidding**

- 3.1. The Bidder shall bear all costs associated with the preparation and submission of its Bid, including cost of presentation for the purposes of clarification of the bid, if so desired by the Client and Client will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the Biding process.
- 3.2. The Bidder is expected to carefully examine all instructions, forms, terms and specifications in the Tender Document. Failure to furnish all information required in the

Tender Document or submission of a bid not substantially responsive to the Bid Document in every respect will be at the Bidder's risk and may result in the rejection of the bid.

#### **4. Amendment in Tender Document.**

- 4.1. At any time up to the last date for receipt of bids, the bidder may, for any reason, whether at his own initiative or in response to a clarification requested by a prospective Bidder, modify the Bid Document by an amendment.
- 4.2. The amendment will be notified on EdCIL website and by e-mail to the prospective Bidders who have received the Bid Documents and will be binding on them.

#### **5. Arbitration**

- 5.1. All disputes or differences, whatsoever, arising between the parties out of or relating to the interpretation, meaning and operation or effect of this contract or the breach thereof, shall be resolved through mutual consultation and negotiation.
- 5.2. Any dispute not resolved by mutual consultations shall be settled through arbitration by arbitrator duly appointed by the Chairman & Managing Director of EdCIL. The award of the said Arbitrator shall be final and binding on both parties. The place of the Arbitration shall be at New Delhi (India). It is the terms of this Contract that in the event of such arbitrator to whom the matter is originally referred, being transferred or on vacating his office, being unable to arbitrate for the aforesaid reason, his successor shall be appointed as Sole Arbitrator by the aforesaid authority and the new incumbent shall resume arbitration proceedings from the stage where his predecessor has left. The Arbitration may from time to time, with the consent of the parties, enlarge the time for making and publishing the award subject to the aforesaid, the Arbitration and Conciliation Act, 1996, shall apply to the aforesaid arbitration proceedings. The performance under this Contract shall not stop for any reason whatsoever during the said dispute / proceedings, unless the supplier / party is specifically directed by EdCIL to desist from working in this behalf. The award of Arbitrator so appointed shall be final and binding upon the parties hereto.
- 5.3. Arbitration cost will be borne jointly by both the parties to the Contract.

## **6. Language of Bids**

The Bids prepared by the Bidder and all correspondence and documents relating to the bids exchanged by the Bidder and the Client, shall be written in the English language, provided that any printed literature furnished by the Bidder may be written in another language so long as accompanied by an English translation in which case, for purposes of interpretation of the bid, the English translation shall govern.

## **7. Documents Comprising the Bids**

The Bids prepared by the Bidders shall comprise of components mentioned below. (Bid documents are to be submitted in the order of eligibility clauses along index page number):

### **7.1. Technical Bid shall consist of the following:**

- 7.1.1. Bid Proposal sheet duly filled in, signed and complete in all respects. (Proforma I)
- 7.1.2. Documentary proof of qualifying the eligibility criteria by the bidder.
- 7.1.3. All proposals must be accompanied by an Earnest Money Deposit (EMD) of Rs.5000/- Five Lakhs Only in the form of Demand Draft in favour of **EdCIL India Ltd.** “Payable at **Noida (U.P.)** in the form of Demand Draft, failing which the bid will be rejected.
- 7.1.4. Technical Compliance as per Proforma III and Compliance Sheet as per note 3 or Scope of work (Section-IV)
- 7.1.5. Detailed technical literature on the quoted product/Brand along with OEM details, specifications, functionalities and other related parameters.
- 7.1.6. The bidder should indicate make & model of the quoted product.
- 7.1.7. Along with technical brochures of the product quoted and also current certifications asked for in the detailed technical specifications should also be enclosed.
- 7.1.8 A marketing brochure of the product may also be enclosed.

## **8. Commercial Bid consisting of the following:**

- 8.1. Price Bid as per the Proforma IV of the tender document.

## 9. Award of the Contract

### 9.1. Technical Evaluation

After short listing based on eligibility criterion, QCBS system of bidding would be followed. The Technical bid will be evaluated by evaluation committee set-up by EDCIL. The following criteria and weightage will be assigned to the technically qualified bidders:

## **10.0 Financial Proposals**

10.1 Bidders shall submit their financial proposals as per the format

10.2 As per the format the cumulative of all total amounts shall be calculated

## **11.0 Final Proposal Evaluation**

a. Technical Score shall be given weightage of 0.7

b. Financial Score shall be given weightage of 0.3

c. Final Score shall be calculated as:

$$\text{Final Score} = T_s \times 0.7 + F_s \times 0.3$$

d. **Bidder with highest Final Score shall be declared selected Bidder.**

e. In the event that two or more Bidders with same final score, the bidder with more marks in technical evaluation shall be selected

## **SECTION – III**

### **TERMS AND CONDITIONS OF THE BID**

#### **1. Standards:**

The Goods supplied under this contract shall conform to the standard mentioned in the Technical Specifications, and when no applicable standards are mentioned, to the authoritative standards, such standard shall be the latest issued by the concerned institution governing that standard.

#### **2. Delivery Period:**

2.1. The delivery period would be 8 weeks from the date of issue of individual sub purchase order after signing of rate contract agreement. These shall not apply in cases of orders where a separate delivery period is communicated at the time of issuance of order based on end client requirement.

2.2. The delivery period should be adhered to as will be mentioned in the Award of Contract. The supply shall actually be deemed to have been complete on the actual date of entire installation of all components/ items as per terms of sub purchase order.

#### **3. Penalties:**

3.1. A delay attributable to the agency in the performance of its obligations shall render him liable to any or all of the following penalties:-

3.1.1. In case of Non / partial supply of the equipment within a stipulated period, penalty @ 1% of total contract value for every week of delay on the defaulted amount.

3.1.2. Hiding of facts, misrepresentation, corrupt practices by the Bidder if revealed at any stage, would lead to forfeiture of EMD and subsequently the firm may also be blacklisted by EdCIL.

#### **4. Standard of Performance**

4.1 The firm shall carry out the supply order and carry out its obligations under the contract with due diligence, efficiency and economy in accordance with generally accepted norms techniques and practices used in the industry. The agency shall also adhere to professional implementation and support services including committed warranty/AMC services during the execution of the project.

Agency shall always act in respect of any matter relating to this contract, as faithful advisors to EdCIL and shall, at all times, support and safeguard EdCIL's legitimate interests in any dealings with the third party.

4.2 The bidder would be required to support the product with all spares/patches etc for the supplied period for a total period of five years from the date of supply.

4.3 Consignee of the product would either be EdCIL or any other entity including end customer as mentioned in the sub purchase order.

## **5. Schedule of Payment**

5.1 EDCIL will release the payment to the bidder on back to back basis on receipt of related payment based on certification of the end customer. The bidder shall submit a PBG of 5% of the order value to EDCIL for every project being awarded under this rate contract.

5.2 The Rate contract is valid for a period of 1 year which can be further extended on mutually agreed terms and conditions for a period of another 2 years. However the supply being of hardware with expected decrease in unit prices the price shall be negotiated. The vendor shall however supply all patches and modifications as may be applicable.

## **6 Taxes and Duties**

The taxes payable shall be extra as applicable in both cases i.e. Indian and International markets. EdCIL would avail CENVAT/ input credit wherever applicable.

## **7 Non-Disclosure**

The bidder and their personnel shall not, either during the term or after expiration of this contract, disclose any proprietary or confidential information relating to the services, contract, terms, prices or the client's business or operations details without the prior written consent of the client. EdCIL would also not disclose similar details without prior approval of the bidder.

## **8 FORCE MAJEURE:**

8.1 Notwithstanding the provisions of the bid, the bidder shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance are other failure to perform its obligations under the contract is the result of an event of Force Majeure.

8.2 For purposes of this Clause, "Force Majeure" means an event beyond the control of the bidder and not involving the bidder and not involving the bidder's fault or negligence and not foreseeable. Such events may include, but are not restricted to, acts

of the client either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- 8.3 If a Force Majeure situation arises, the bidder shall promptly notify the client in writing of such conditions and the cause thereof. Unless otherwise directed by the client in writing, the bidder shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. The client may terminate this contract, by giving a written notice of minimum 30 days to the bidder, if as a result of Force Majeure, the bidder being unable to perform a material portion of the services for a period of more than 60 days.
