2. No bids after the last date and time shall be entertained.
3. Earnest Money Deposit (EMD): EMD of Rs. 7,000/- (Rupees Seven Thousand only) by Demand Draft only drawn in favor of 'EdCIL (India) Limited' Payable at Delhi/Noida. Any bid received without EMD will be rejected summarily. However, Bidders registered with DGS&D, NSIC or MSEs for this purpose are exempted from payment of EMD subject to submission of relevant exemption certificate from the authorities.
4. Forfeiture of Earnest Money:
 - 3.1 If the Bidder withdraws his bid before the expiry of validity or after the acceptance of the bid, the Earnest Money Deposited by the bidder will be forfeited.
 - 3.2 If the Bidder fails to comply with any of the terms, conditions or requirement of order and the technical specifications of the tender document. The Earnest Money deposited by the Bidder will be forfeited.
 - 3.3 In case successful bidder fails to comply with the delivery period as specified the earnest money deposit will be forfeited.
5. The successful supplier will submit a Bank Guarantee equivalent to 5% of the total value of purchase order at the time of installation which would remain valid for a period of 60 days beyond the date of completion of all obligations of the supplier including warranty obligation. EMD will be released to successful bidder after submission of Bank Guarantee. EdCIL shall forfeit Bank Guarantee in the event of a breach of contract by the successful supplier.
6. Bid would be rejected for award if it is determined that the bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the contract in question.

7. The Bids received after the deadline for submission of quotations prescribed by the EdCIL will be rejected and such bids shall be marked as late and not considered for further evaluation.
8. EdCIL may, at its discretion, extend the deadline for submission of bids by amending the bid documents in accordance with clause relating to Amendment of Bidding documents in which case all rights and obligations of the EdCIL and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
9. The original and all copies of the bid shall be typed or written in indelible ink and shall be signed by the bidder or a person or persons duly authorized to bind the bidder to the Contract. All pages of the bid, shall be initialed by the person or persons signing the bid. Further, over-writings on documents, if any should be supported by signatures.
10. The bidders may submit their duly sealed Bid by post or by hand at the address specified in the Bid Document not later than the time and date specified therein. In the event of the specified date for the submission of bid being declared a holiday for EdCIL, the bid will be received up to the appointed time on the next working day.
11. Issuance of bid documents should not automatically be construed that the bidder is considered qualified. EdCIL shall have the right to reject any bids without assigning any reason.
12. EdCIL shall not be responsible for any delay, loss or non-receipt of bid documents sent by post.
10. Prices shall be quoted in Indian Rupees.
11. 100% Payment shall be made after delivery, successful installation, commissioning & submission of Bank Guarantee.
12. All taxes, if applicable, should be quoted separately, otherwise it would be presumed that the quoted prices are inclusive of taxes (please see Financial Bid format).
13. Prices quoted should be inclusive of all charges required to make the software functional to the satisfaction of EdCIL, otherwise it would be presumed that the quoted prices are inclusive of all charges, as applicable.
14. Supply, Installation and Commissioning of the Software should be completed within 15 days from the date of Purchase Order.

15. The suppliers will undertake warranty of software from the date of installation and shall have to mention clearly the period of warranty in financial bid.
16. The quotation must be valid for 90 (Ninety) days from the date of opening of the financial bids. No change in prices and change in terms and conditions will be permitted.
17. Installation, testing, commissioning of the software should have to be carried out by Technical experts of the supplier up to the satisfaction of user department of EdCIL
18. Free training shall be imparted to faculty/technical staff for operation, maintenance and troubleshooting at the user department of EdCIL.
19. In the process of evaluation, comparison of bids, EdCIL reserves the right to reject any or all bids.
20. All corrigenda will only be notified on the EdCIL website.
21. EdCIL (India) Ltd., NOIDA shall be the final Authority for settlement of any dispute and it's interpretation of any Clause/term/condition(s) of this document shall be final and binding and the jurisdiction for Court of Law shall be Delhi/New Delhi.
22. The bid submitted by the vendors will be evaluated independently to arrive at the L-1 price, which is the sole discretion of this corporation. Further, the Corporation does not bind itself to accept the lowest tender or assign any reason for non-acceptance of the same.
23. Agencies, which have failed to fulfill earlier contractual obligations, may not be considered.
24. The bid should be free from overwriting. All corrections and alteration should be duly attested by the vendor/tenderer.
25. The bid should be unambiguous in all respects.
26. DISPUTE RESOLUTION and JURISDICTION

If any dispute difference of any kind whatsoever shall arise between the parties in connection with or arising out of this Agreement or out of the breach, termination or invalidity of the Agreement hereof, the parties shall resolve them by resort to the following in the order so mentioned. Parties shall attempt for a period of 30 days after receipt of notice by the other party of the existence of a dispute to settle such dispute in the first instance by mutual discussions between the parties.

If the dispute cannot be settled by mutual discussions within 30 days as provided herein, the dispute shall be referred to the sole arbitration of an arbitrator appointed by the Chairman & Managing Director (C&MD) of EdCIL or his nominee. The party

having a grievance shall serve a written notice by registered acknowledgement due post, on the other party intimating its intention of invoking the arbitration clause and shall simultaneously serve a notice in the similar mode on C&MD, EdCIL requesting him to appoint an arbitrator.

The arbitration proceedings shall be held in accordance with the provisions of Arbitration and conciliation Act, 1996 or any statutory modifications or re-enactment thereof venue of arbitration shall be Noida and both the parties to this agreement shall bear the cost of arbitration equally. Parties agree that neither party shall have a right to commence or maintain any suit or Legal proceeding concerning any dispute arising out of this Agreement or out of the breach, termination or in validity or the Agreement until the dispute has been determined in accordance with the arbitration procedure agreed herein. The parties further agree that the award shall be final and binding on the parties to this Agreement.
